Our first speaker will be **Porus Kaka** from India, our new President of International Fiscal Association - Worldwide as from September 2013. Our international speakers include **Professor Michael Lang** from Austria, **Professor Jeffrey Owens** (ex head of OECD, Paris) now Director of the Global Tax Policy Center at WU in Vienna; and **Professor Arvid Skaar** from Oslo, a recognised global expert on issues involving taxation of permanent establishments.
