

Sub: - Extension request for filing web-form 11 (Annual Return of LLP) due to technical Challenges faced while filling as well as Filing Form 11 by using MCA21 V3 version

The Chamber of Tax Consultants, established in 1926, is one of the oldest non-profit organizations of tax practitioners, having Advocates, Chartered Accountants and Tax Practitioners as its members spread across Pan India. Many senior tax professionals who regularly appear before ITAT, High Courts and the Supreme Court are its Past Presidents. It has from time to time made various representations to different Government Authorities drawing their attention to pressing issues.

The Ministry of Corporate Affairs (MCA) had migrated all the LLP e-filing Services to MCA V3 portal which also includes Form 11 i.e. Annual Return of Limited Liability Partnership (LLP). Further as per provisions of Limited Liability Partnership Act, 2008, LLP is required to file Annual return (Form – 11) within 60 days of close of financial year i.e. last date to file Form-11 for this year will be 30th May, 2022. However, we are facing technical errors while filling as well as filing the form. The errors faced till time are compiled and enlisted in below table:

Sr. No.	Particulars of Errors faced
1.	Error while getting data pre-filled in the form
2.	Downloaded version of Form does not contain all the details which appears in Web-Form
3.	Details of Striked off LLPs are showing up instead of Active LLP in the Form

4.	Details of Nominee appointed by Body Corporate as Designated Partner is getting pre-filled in details of Partner instead of Name of Body Corporate
5.	There is mismatch in pre-filled information w.r.t appropriate details of Contribution and details of Partners are not appearing in the form
6.	Mismatch in details of Partner i.e. person who is no longer partner in LLP is appearing in Form 11
7.	Error while submitting the Form although it is completed in all respects

As enlisted in above table, stakeholders are facing practical difficulties in filling as well as filing of Form-11, and if stakeholders will not be able to file the Form 11 till 30th May, 2022, then additional fees of Rs. 100/- per day will get attracted and they have to bear it unnecessarily i.e. without any default or delay in filing from their side.

Therefore, we request your good office to grant relaxation or extend the due date of filing Form -11 till all the enlisted technical glitches are addressed to enable stakeholders to file the form.
